

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 6460

A BY-LAW to amend By-Law No. 6333, being the
"Burnaby Building By-Law 1973".

The Council of The Corporation of the District of Burnaby
ENACTS as follows:

1. This By-law may be cited as "BURNABY BUILDING BY-LAW 1973,
AMENDMENT BY-LAW 1974".
2. Appendix "A" of By-Law No. 6333 is repealed and the follow-
ing substituted therefor:

"APPENDIX "A"

Building Permit Fee Payable by Applicant for a Permit
for the Construction of a Building or any part thereof

Value of the Work to be done	Fee for a Building or part thereof other than an Apartment Building	Fee for an Apartment Building or part thereof
\$0 - \$200	\$5.00	---
\$201 - \$500	\$7.50	\$10.00
\$501 - \$1,000	\$10.00	\$20.00
\$1,001 - \$15,000	\$10.00 plus \$4.00 for every \$1,000 or part thereof over \$1,000	\$20.00 plus \$4.00/ \$1,000 or part thereof over \$1,000
\$15,001 - \$50,000	\$66.00 plus \$2.50/ \$1,000 or part thereof over \$15,000	\$76.00 plus \$3.00/ \$1,000 over \$15,000
\$50,001 and over	\$153.50 plus \$1.50/ \$1,000 or part thereof over \$50,000	\$181.00 plus \$1.75/ \$1,000 or part thereof over \$50,000."

3. Clause (a) of subsection (3) of section 4 of By-Law No.
6333 is amended by striking out the figures "\$25.00" in the third line
and substituting therefor the figures "\$50.00".
4. Subsection (4) of section 5 of By-Law No. 6333 is repealed
and the following substituted therefor:

"5. (4) If an owner requests an inspection for which no fee is herein prescribed, he shall pay to the Corporation a fee based on the time taken to make such inspection at the rate of \$20.00 per hour for the first hour or part thereof and \$10.00 per hour for each additional hour or part thereof."

5. This by-law shall come into force and take effect on the 1st day of April, 1974.
