

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 6654

A BY-LAW to reserve certain lands owned by the Municipality of Burnaby for park purposes.

WHEREAS the Council of a district municipality may by by-law reserve for a particular municipal or other public purpose any land owned by the municipality.

AND WHEREAS The Corporation of the District of Burnaby is a district municipality.

AND WHEREAS the lands hereinafter described are owned by The Corporation of the District of Burnaby.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This by-law may be cited as "BURNABY PARKS RESERVATION BY-LAW 1975".
