

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 6931

A BY-LAW to dedicate certain real property owned by the Municipality for park, pleasure, recreation, or community uses of the public.

WHEREAS the Council of a city, town, district or village municipality may, with the assent of the electors, by by-law dedicate for public purposes any real property owned by the Municipality.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY EASTERN BURRARD INLET FORESHORE PARK DEDICATION BY-LAW 1976".
2. The Council does hereby dedicate for park, pleasure, recreation, or community uses of the public that real property owned by the Municipality, more particularly described as follows:
 - (a) Part 6.08 acre portion shown on Sketch 3819 and lettered "A", Block 2, District Lot 215, Group 1, Plan 3082, New Westminster District;
 - (b) Block 2, District Lot 215, Group 1, Plan 3082, New Westminster District, Except Firstly Part 6.08 acres shown on Sketch 3819 and Secondly, that portion subdivided by Plan 3575;
 - (c) Block 4, District Lot 214, Group 1, Plan 3081, New Westminster District, Except Part subdivided by Plan 7060;
 - (d) Lot "B", Blocks 4, 7 and 8, District Lot 214, Group 1, Plan 7060, New Westminster District;
 - (e) Block "A" of Blocks 8, 9 and 12 of District Lots 213 and 214, Group 1, Plan 6584, New Westminster District;
 - (f) Lot 2 of District Lot 214 and Tidal Lands fronting District Lot 214, Group 1, Plan 49510, New Westminster District;

- (g) Lot 1 of District Lot 213, Group 1 and of Tidal Lands in front of District Lot 213, Group 1, Plan 47520, New Westminster District;
- (h) Lot 2 of District Lot 213, Group 1 and of Tidal Lands in front of Lot 213, Group 1, Plan 47520, New Westminster District;
- (i) Lot "D" of Tidal Lands in front of District Lot 213, Group 1, Plan 6258, New Westminster District;
- (j) Block 14 of District Lot 213, Group 1, Plan 3081, New Westminster District;
- (k) Block 5, District Lot 212, Group 1, Plan 3080, New Westminster District;
- (l) Block 7, District Lot 212, Group 1, Plan 3080, New Westminster District; and
- (m) Block 4, District Lot 215, Group 1, Plan 3082, New Westminster District.

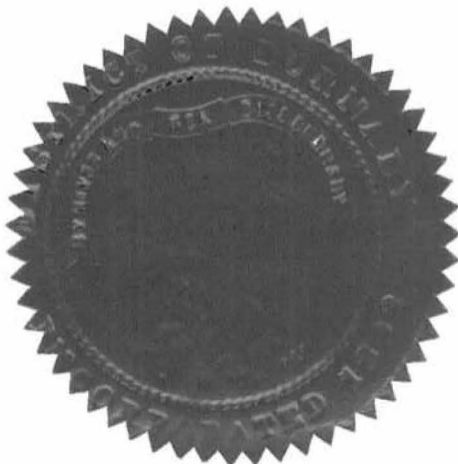
