THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 7070

A BY-LAW to authorize the expropriation of certain real property for the widening of Norland Avenue.

WHEREAS it is deemed necessary and in the public interest to expropriate the real property hereinafter described for the widening of Norland Avenue.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY EXPROPRIATION BY-LAW NO. 5, 1977".
- 2. For the widening of Norland Avenue, the Council is hereby authorized and empowered, without the consent of the owners of the real property but subject to the provisions of Division (4) of Part XII of the Municipal Act, by its servants and agents to enter upon, expropriate, break up, take, enter into possession of and use those certain parcels of real property situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, shown outlined in red on plan prepared by Bryan S. Berting, B.C.L.S., sworn the 4th day of March, 1977 and deposited in the Land Registry Office at New Westminster, in the Province of British Columbia, under Number 52300, more particularly described as follows:
 - (a) That portion of the North West 1/2 of Lot 10, Block "A" of Block 1, District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 660 square feet, more or less;

- (s) That portion of Lot 7, Block "D" of Block 1, District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 1,208 square feet, more or less;
- (t) That portion of Lot 6, Block "D" of Block 1, District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 1,208 square feet, more or less;
- (u) That portion of Lot 5, Block "D" of Block 1, District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 1,208 square feet, more or less;
- (v) That portion of Parcel "A" of Lot 4, Block "D", District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 605 square feet, more or less;
- (w) That portion of Lot 4, Block "D", District Lot 75, Group 1, Plan 4147, Except Parcel "A", New Westminster District, containing by admeasurement 605 square feet, more or less;
- (x) That portion of Lot 3, Block "D" of Block 1, District Lot 75, Group 1, Plan 4147, New Westminster District, containing by admeasurement 1,210 square feet, more or less.
- 3. The Council is further authorized and empowered by its servants and agents to enter upon any real property which may be injuriously affected by the exercise of the powers in this by-law granted for the purpose of executing any works of construction, maintenance and repair in mitigation of injury done or apprehended or in reduction of compensation.
- 4. This by-law shall, before coming into effect, be published once in the B. C. Gazette and in a newspaper published or circulating in the Municipality of Burnaby and a certified copy of

the by-law shall be filed in the Land Registry Office at New West-minster, in the Province of British Columbia.
