That portion of road situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being described as that portion of District Lot 127, Group 1, New Westminster District, Plan 4953, containing by admeasurement 6,693 square feet, more or less, shown outlined in red on the plan annexed hereto prepared by Dick F. Mak, B.C.L.S., certified correct the 27th day of October, 1977, is hereby stopped up and closed to traffic.
- 3. The Mayor and Clerk are hereby authorized and empowered to petition the Minister of Municipal Affairs and Housing to abandon the said portion of road and vest title thereto in the name of The Corporation of the District of Burnaby.


