> A BY-LAW to amend By-Law No. 3089 , being the "Burnaby Trades Licence By-Law 1950"

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY TRADES LICENCE BY-LAW 1950, AMENDMENT BY-LAW NO. 2, 1977'.
2. Section 9 of By-Law No. 3089 is repealed and the following substituted therefore:
"9. Unless otherwise specified herein all licences granted under this by-law shall be for the current calendar year and shall expire on the 3lst day of December next succeeding the date of issue of same."
3. Schedule "A" annexed to By-Law No. 3089 is repealed and Schedule "A" annexed hereto substituted therefor.
4. This By-Law shall come into force and effect on the lst day of January, 1978.
