

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7166

A BY-LAW to amend By-Law No. 3325, being the  
"Burnaby Waterworks Regulation By-Law  
1953".

The Council of The Corporation of the District of Burnaby  
ENACTS as follows:

1. This By-law may be cited as "BURNABY WATERWORKS REGULATION  
BY-LAW 1953, AMENDMENT BY-LAW 1978".

2. Section 6 of By-Law No. 3325 is amended by striking out  
the words "thirty inches" therein and substituting therefor "762 mm".

3. Section 21 is repealed and the following substituted  
therefor:

"21. When the consumer whose water service is metered shall  
make a complaint that any bill is excessive, the District will, on  
the written request of the consumer, have such meter reread and the  
service inspected for leaks. Should such consumer desire that any  
meter be tested, the District will test the meter on the written  
request of the consumer and upon deposit with the Treasurer the  
following fee:

For 16 mm, 19 mm, 25 mm, 32 mm, or 38 mm meters	\$ 3.00
For 50 mm meters	5.00
For 76 mm meters	10.00
For 102 mm meters	10.00
For 152 mm meters and meters over 152 mm	20.00

The consumer may be present at such a test."

4. Clause (b) of subsection (1) of section 40 is repealed  
and the following substituted therefor:

"40.(1)(b) the water supplied exceeds 850 cubic metres  
monthly."

5. Schedule 'A' is repealed and the following substituted therefor:

"SCHEDULE 'A'"

FLAT RATES

(1) A detached single-family residence shall pay an annual charge of \$42.00.

(2) A commercial premises comprising not more than three stores or offices and living quarters for one family only shall pay an annual charge of \$84.00.

(3) A commercial premises comprising not more than three stores or offices without living quarters shall pay an annual charge of \$42.00.

(4) A single-family residence within a duplex shall pay an annual charge of \$31.50.

(5) A single-family residence within a multiple-family building (not including a duplex) used exclusively for residential purposes shall pay an annual charge of \$24.00.

MONTHLY METER RATES

(1) For the first 300 cubic metres used, 12.7¢ per cubic metre per month.

(2) For the next 550 cubic metres used, 9¢ per cubic metre per month.

(3) For the next 1400 cubic metres used, 7¢ per cubic metre per month.

(4) For the next 12,000 cubic metres used, 6¢ per cubic metre per month.

(5) For all water used in excess of 14,250 cubic metres, 5.3¢ per cubic metre per month.

(6) The minimum monthly charge for water supplied shall be \$3.50.

QUARTERLY METER RATES

(1) For the first 900 cubic metres used, 12.7¢ per cubic metre per quarter.

(2) For the next 1650 cubic metres used, 9¢ per cubic metre per quarter.

(3) For the next 4200 cubic metres used, 7¢ per cubic metre per quarter.

(4) The minimum quarterly charge for water supplied shall be \$10.50.

CONNECTION FEES

The following fees shall be paid for water service connections:

Up to and including 19 mm connection	\$ 350.00
Over 19 mm connection	Actual Cost."

Read a third time this 3rd day of January, 1978.

Received the approval of the Minister of Municipal Affairs and Housing this 8th day of March, 1978.

Reconsidered and adopted this 20th day of March, 1978.
