Mak, B.C.L.S., and containing by admeasurement 426 square feet, certified correct the 24th day of January, 1978, is hereby stopped up and closed to traffic.

3. The Mayor and Clerk are hereby authorized and empowered to petition the Minister of Municipal Affairs and Housing to abandon the said portion of road more particularly described in Section 2 hereof and vest title thereto in the name of The Corporation of the District of Burnaby.
