THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7233

A BY-LAW to authorize the use of unexpended moneys borrowed under authority of certain Security Issuing By-Laws.

WHEREAS Council from time to time has adopted the security issuing by-laws more particularly enumerated in Schedule "A" annexed hereto to raise in aggregate the sum of \$8,960,580.00 to finance the cost of constructing local improvement works more particularly described in the said by-laws.

AND WHEREAS the said money has been borrowed.

AND WHEREAS the said local improvement works have been constructed and the costs thereof have been fully paid.

AND WHEREAS the Treasurer has certified that there is now an unexpended balance of the moneys so borrowed in the amount of \$161,492.24 as outlined in Schedule "A" annexed hereto.

AND WHEREAS Council may by by-law, with the approval of the Inspector of Municipalities, provide for the use of such unexpended balances for expenditures of a nature similar to the purpose specified in the by-law under which the moneys were authorized to be borrowed.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

 This By-law may be cited as "BURNABY USE OF SURPLUS FUNDS BY-LAW 1978".

2. The Treasurer is hereby authorized and empowered to apply the said sum of \$161,492.24 to finance the works outlined in Schedule "B" annexed hereto in the manner therein set forth.


