BY-LAW NO. 7271

A BY-LAW to establish four mobile polls for the municipal elections, including submissions to the electors, on November 18, 1978.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This By-law may be cited as "BURNABY MOBILE POLL BY-LAW 1978".
- The Returning Officer shall establish for the municipal elections, including submissions to the electors, on November 18, 1978 four mobile polls and each mobile poll shall be staffed by a Deputy Returning Officer and two Poll Clerks.
- 3. The first mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
 - (a) Burnaby General Hospital, 3800 Ingleton Avenue, from 8:00 o'clock in the forenoon until 3:30 o'clock in the afternoon;
 - (b) Carlton Private Hospital, 4125 Canada Way, from 3:45 o'clock in the afternoon until 4:30 o'clock in the afternoon;
 - (c) Central Park Manor, 3730 Burke Street, from 6:00 o'clock in the afternoon until 7:45 o'clock in the afternoon.
 - 4. The second mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
 - (a) Seton Villa, 3755 McGill Street, from 8:00 o'clock in the forenoon until 12:30 o'clock in the afternoon;

- (b) Fellburn Private Hospital, 6050 East Hastings Street, from 1:30 o'clock in the afternoon until 2:15 o'clock in the afternoon;
- (c) Finnish Manor Personal Care Home, 3460 Kalyk Avenue, from 2:30 o'clock in the afternoon until 4:30 o'clock in the afternoon;
- (d) Dania Home, 4279 Norland Avenue, from 5:45 o'clock in the afternoon until 7:45 o'clock in the afternoon.
- 5. The third mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
 - (a) George Derby H. & O. Centre, 7502 Cumberland

 Street, from 8:00 o'clock in the forenoon until

 12:00 o'clock noon;
 - (b) Normanna Rest Home, 7979 12th Avenue, from 1:00 o'clock in the afternoon until 2:45 o'clock in the afternoon;
 - (c) Deer Lake Private Hospital, 6907 Elwell Street, from 3:00 o'clock in the afternoon until 3:30 o'clock in the afternoon;
 - (d) Hall Towers #2 -(Second and Third Floors),
 7264 Kingsway, from 3:45 o'clock in the afternoon
 until 4:45 o'clock in the afternoon;
 - (e) Dogwood Lodge, 3755 Willingdon Avenue, from 6:00 o'clock in the afternoon until 7:45 o'clock in the afternoon.
- 6. The fourth mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:

- (a) New Vista Care Home, 7550 Rosewood Street, from 8:00 o'clock in the forenoon until 12:00 o'clock noon;
- (b) Canada Way Personal Care Centre, 7195 CanadaWay, from 1:00 o'clock in the afternoon until4:00 o'clock in the afternoon;
- (c) Fair Haven, 4341 Rumble Street, from 5:30 o'clock in the afternoon until 7:45 o'clock in the afternoon.
