BY-LAW NO. 7289

A BY-LAW to Stop Up and Close to Traffic  
a Portion of Road

WHEREAS that portion of road shown outlined in red on the plan annexed hereto dedicated by Plan 3046 is no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 8, 1978".
2. That portion of road situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being a portion of lane in Block 14, District Lot 13, Group 1, Plan 3046, New Westminster District, shown outlined in red on plan attached hereto prepared by Bryan S. Berting, B.C.L.S., certified correct the 6th day of November, 1978 and containing by admeasurement 0.009 ha, is hereby stopped up and closed to traffic.
3. The Mayor and Clerk are hereby authorized and empowered to petition the Minister of Municipal Affairs and Housing to abandon the said portion of road more particularly described in Section 2 hereof and vest title thereto in the name of The Corporation of the District of Burnaby.

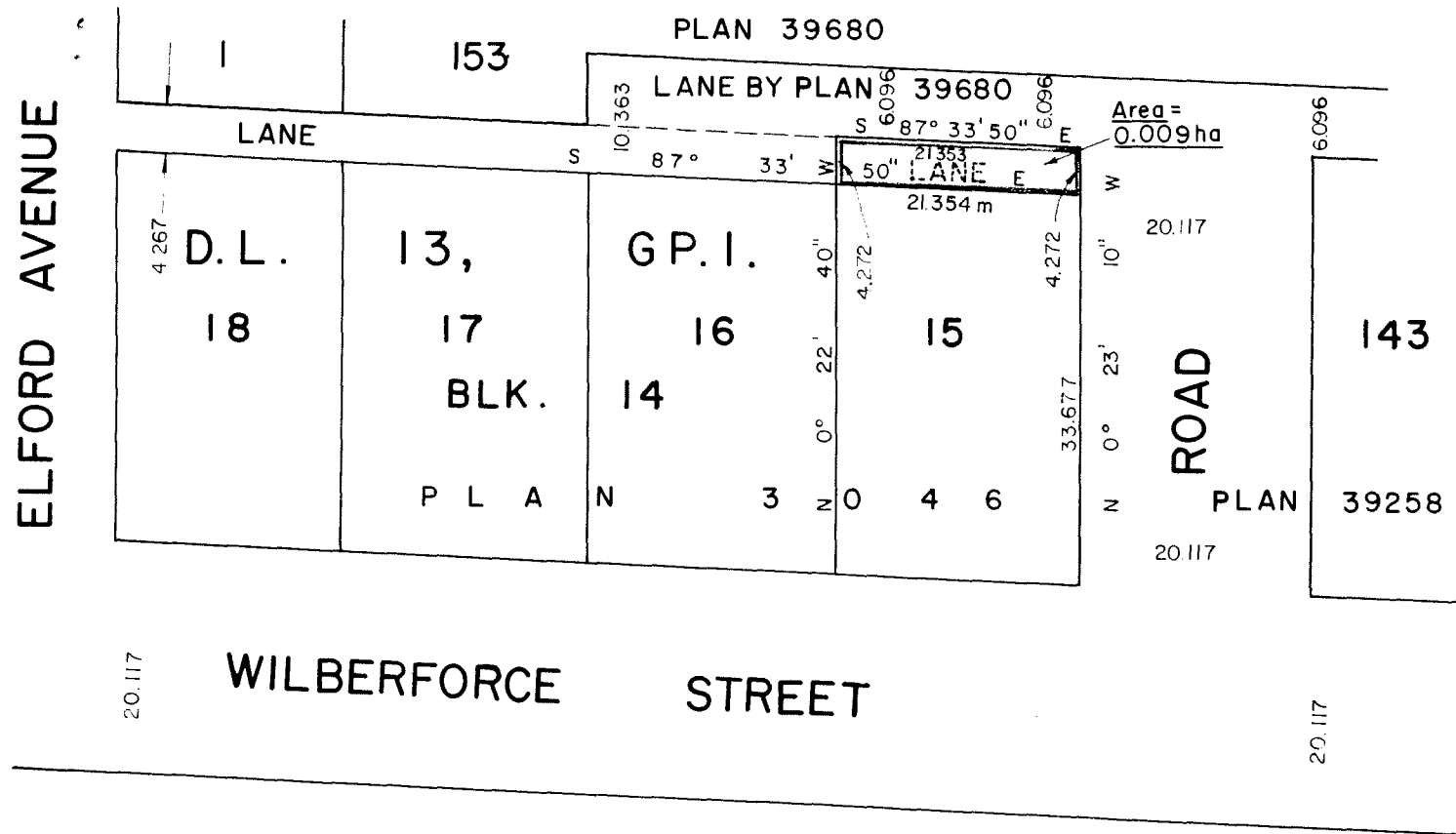
BY-LAW PLAN TO ACCOMPANY THE CORPORATION OF THE
