

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7446

A BY-LAW to amend By-Law No. 4231, being the
"Burnaby Sewer Charge By-Law 1961"

The Council of The Corporation of the District of Burnaby

ENACTS as follows:

1. This By-law may be cited as "BURNABY SEWER CHARGE BY-LAW 1961, AMENDMENT BY-LAW NO. 2, 1979".
2. Subsection (1) of section 2 of By-Law No. 4231 is repealed and the following substituted therefor:
 - "2. (1) Unless in this by-law otherwise provided, the owner or occupier of every parcel of real property shall pay to the municipality for the use of the sewerage system a charge calculated according to the quantity of water delivered by the municipal water utility to the parcel of real property and the table of rates set out in Schedule "A" annexed hereto."
3. Section 4A of By-Law No. 4231, as enacted by By-Law No. 7366, is repealed and the following substituted therefor:
 - "4A (1) The users classified hereunder shall pay for the use of the municipal sewerage system the annual charge hereinafter specified:
 - (a) The owner of any strata lot (not being part of a duplex) shall pay an an annual charge of \$31.20.
 - (b) The owner of any multiple-family dwelling (except a duplex) used exclusively for residential purposes shall pay for each apartment unit therein an annual charge of \$31.20.
 - (c) The owner of an apartment unit forming part of a duplex shall pay an annual charge of \$14.45.

(2) The charges payable pursuant to this section shall be collected in the same manner and with like remedies as ordinary taxes upon land and improvements are collectable under the Municipal Act."

4. Schedule "A" of By-Law No. 4231, as enacted by By-Law No. 7366, is repealed and Schedule "A" annexed hereto substituted therefor:

5. This By-law shall come into force and effect on the 1st day of January, 1980.
