

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7526

A BY-LAW to exempt certain defined classes of shops from the provisions of section 920 of the Municipal Act. R.S.B.C. 1979

WHEREAS for the local convenience and well-being of the residents of the municipality, the Council may by by-law exempt completely from section 920 of the Municipal Act R.S.B.C. 1979 any defined class or classes of shops.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This by-law may be cited as "BURNABY SHOPS STATUTORY HOLIDAYS EXEMPTION BY-LAW 1980".

2. In this by-law

(a) "Auction" means a place where the sole business carried on is the sale of goods by public auction.

(b) "Automobile Dealer" means a shop where the principal or only trade or business is the sale by retail of one or more of the following products:

- (i) New Automobiles, including trucks;
- (ii) Used Automobiles, including trucks;
- (iii) Motorcycles;
- (iv) Trailers;
- (v) Parts for automobiles, trucks, motorcycles and trailers.

(c) "Bookstore" means a shop devoted exclusively to the sale of books and periodicals.

(d) "Camp Supply Store" means a shop dealing in camping equipment.

(e) "Corner Store" means a shop dealing primarily in groceries, having a shop floor area of less than 1,500 square feet (139m²) operated by a family and employing not more than one other person.

(f) "Customer Operated Dry Cleaning Establishment" means a shop where the principal or only trade or business is the sale by retail of the right by members of the general public to clean textiles, fabrics, garments and other articles by use of a dry cleaning machine utilizing a solvent other than water.

(g) "Customer Operated Laundry" means a shop where the principal or only trade or business is the sale by retail of the right by members of the general public to clean textiles, fabrics, garments and other articles by use of a laundry machine utilizing water as a solvent.

(h) "Drug Store" means a shop operated in conjunction with a Pharmacy having a registered Pharmacist in attendance for at least a portion of the days when such shop is open for business and where the principal or only trade or business, apart from the dispensing of prescribed drugs, is the sale by retail of one or more of the following lines of goods:

- (i) Proprietary Drugs;
- (ii) Smokers' Supplies;
- (iii) Cosmetics;
- (iv) Magazines;
- (v) Stationery and School Supplies;
- (vi) Candies and Soft Drinks;
- (vii) Toys;
- (viii) Notions.

3. For the local convenience and well-being of the residents of the municipality, Council does hereby exempt completely from the provisions of section 920 of the Municipal Act R.S.B.C. 1979

- (a) Auction
- (b) Automobile Dealer
- (c) Bookstore
- (d) Camp Supply Store
- (e) Corner Store
- (f) Customer Operated Dry Cleaning Establishment
- (g) Customer Operated Laundry
- (h) Drug Store
