

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 7551

A BY-LAW to authorize the acquisition and dedication of certain lands for road purposes.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 1, 1980".
2. The Council does hereby establish as a public highway those municipally-owned lands described as those portions of Lots 23, 24, 25 and 26, Block 2, District Lot 90, Group 1, Plan 555, New Westminster District, shown outlined on plan prepared by Bryan S. Berting, B.C.L.S. (hereinafter called "the said plan"), a copy of which is hereunto annexed, each containing by admeasurement 0.0093 ha.
3. The Council is hereby authorized and empowered to acquire from the registered owners thereof by a good and sufficient transfer registrable under the Land Title Act free and clear of all encumbrances for highway purposes those portions of the lands hereinafter more particularly described shown outlined on the said plan:
 - (a) Lot 44 of Lot 2, District Lot 90, Group 1, Plan 555, Except the easterly 20' (included in Parcel "G" Explanatory Plan 13695) New Westminster District;
 - (b) Lot 45, Block 2, District Lot 90, Group 1, Plan 555, Except the westerly 30' (Explanatory Plan 13695) New Westminster District;

(c) Parcel "G" (Explanatory Plan 13695)
of Lots 44 and 45, Block 2 of District
Lot 90, Group 1, Plan 555, New Westminster
District.

Reconsidered and adopted this 8th day of September 1980.



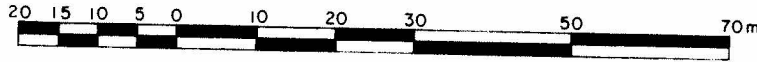

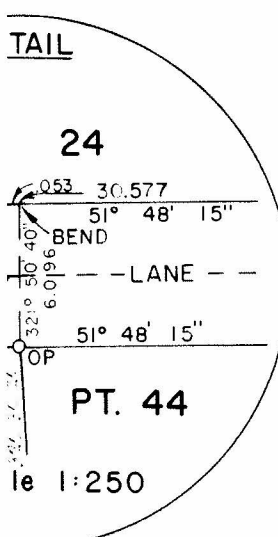
