BY-LAW NO. 7566

A BY-LAW to amend By-Law No. 4742, being
"Burnaby Zoning By-Law 1965"

WHEREAS application for rezoning has been made to the
Council.

AND WHEREAS the Council has held a public hearing thereon
after duly giving notice of the hearing as prescribed by section 720
of the Municipal Act R.S.B.C. 1979.

NOW THEREFORE the Council of The Corporation of the
District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY ZONING BY-LAW 1965,
AMENDMENT BY-LAW NO. 42, 1980".
2. By-Law No. 4742 is amended by rezoning Lots 18, 19 Except
N. 16 ft., and 20, Block 30, District Lot 152, Group 1, Plan 1520, New
Westminster District, shown on plan annexed hereto and marked Schedule
"A" as Comprehensive Development (CD) and the Map attached to and form-
ing an integral part of By-Law No. 4742 and designated as the Official
Zoning Map of The Corporation of the District of Burnaby is amended
accordingly.
3. The Comprehensive Development Plan entitled "Office
Building Development" prepared by Maxwell, Bailey, McInerney, Consulting
Engineers Ltd., on file in the office of the Director of Planning is
deemed to be attached to and form part of this by-law.

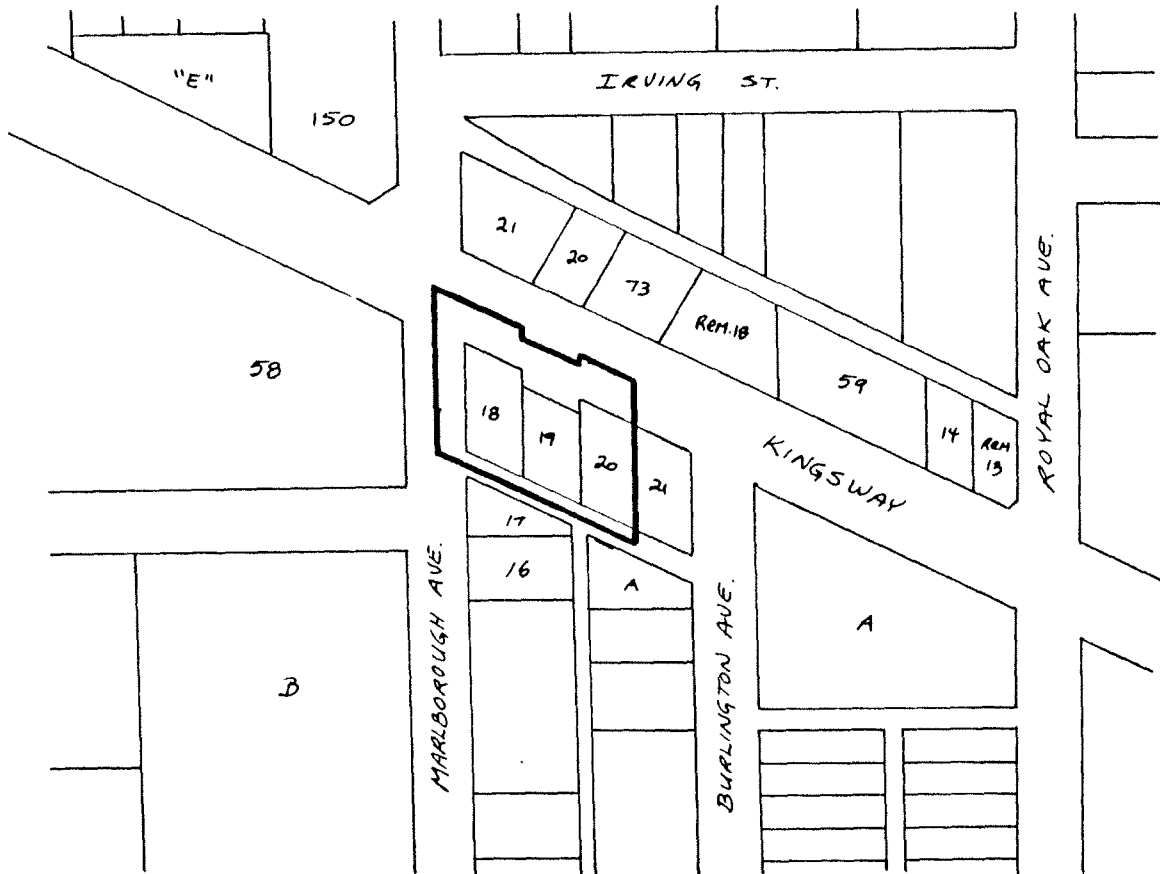
