1. This By-law may be cited as "BURNABY TRADES LICENCE  
BY-LAW 1950, AMENDMENT BY-LAW 1980".
2. Schedule "A", annexed to By-Law No. 3089, as enacted  
by By-Law No. 7449, is repealed and Schedule "A" annexed hereto  
substituted therefor.
3. This by-law shall come into force on the 1st day of  
January, 1981.
