



## THE CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 7625

#### A BY-LAW to authorize the use of unexpended moneys borrowed under authority of certain Security Issuing By-Laws

WHEREAS Council has adopted Security Issuing By-Laws Nos. 6607 and 6695 to raise in aggregate the sum of \$2,120,000.00 to finance the cost of park land acquisitions more particularly described in the said by-laws.

AND WHEREAS the said money has been borrowed.

AND WHEREAS the said park land has been acquired and the costs thereof have been fully paid.

AND WHEREAS the Treasurer has certified that there is now an unexpended balance of the moneys so borrowed in the amount of \$237,159.53 (hereinafter called "the said unexpended balance").

AND WHEREAS Council may by by-law, with the approval of the Inspector of Municipalities, provide for the use of such unexpended balances for expenditures of a nature similar to the purpose specified in the by-law under which the moneys were authorized to be borrowed.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This By-law may be cited as "BURNABY SURPLUS FUNDS BY-LAW 1981".

2. The Treasurer is hereby authorized and empowered to apply the sum of \$216,400.00 from the said unexpended balance to finance the works





outlined in Schedule "A" annexed hereto in the manner therein set forth.


