3. This By-Law shall come into force and take effect on the date of its final adoption.

Fee payable by applicant for a permit for  
the installation of electrical equipment

1. Minimum residential fee.....\$ 11.50
2. Minimum commercial fee.....\$ 25.00
3. Miscellaneous inspections (per hour).....\$ 25.00
4. Temporary current permit.....\$ 11.50
5. Reinspection permit.....\$ 25.00
6. Annual permits:
  - (a) Minimum fee.....\$ 48.50
  - (b) Maximum fee.....\$1,764.00
  - (c) Per KVA of service capacity.....\$ .10
7. Fee schedule based upon the value of the proposed electrical installation including all material and labour.
