BY-LAW NO. 7644

A BY-LAW to Close Certain Portions of Public Highway

WHEREAS those lands more particularly hereinafter described were dedicated as public highway by By-Law No. 4721, being the "BURNABY ROAD ACQUISITION AND DEDICATION BY-LAW NO. 8, 1965";

AND WHEREAS a certified copy of the said by-law was deposited in the Land Title Office under No. A27214;

AND WHEREAS the said lands are no longer required as a public highway and it is deemed desirable and in the public interest to close the said lands as public highway;

AND WHEREAS the said lands are vested in The Corporation of the District of Burnaby;

NOW THEREFORE the Council of The Corporation of the District of Burnaby enacts as follows:

- This By-Law may be cited as "BURNABY ROAD CLOSING BY-LAW NO. 1, 1981".
- Those lands hereinbefore referred to and dedicated as public highway, more particularly described in Schedule A annexed hereto, are hereby stopped up and closed to the free passage of the public.
- 3. Upon deposit of a certified copy of this by-law in the Land Title Office the said lands referred to in section 2 of this by-law shall cease to be a public highway.
- 4. This by-law shall come into force and effect upon the final adoption thereof.

Read a first time this 23rd day of March 1981. Read a second time this 23rd day of March 1981. Read a third time this 23rd day of March 1981. Reconsidered and adopted this 6th day of April 1981.
