

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 7824

A BYLAW to exempt from taxation certain lands within the Municipality, pursuant to Section 398 (h) and (k) of the Municipal Act.

WHEREAS pursuant to clause (k) of section 398 of the Municipal Act, every building including the land upon which such building actually stands, of which an incorporated institution of learning regularly giving to children instruction accepted as equivalent to that furnished in a public school is the registered owner, or owner under agreement, and which is in actual occupation by such institution and is wholly in use for the purpose of furnishing such instruction, and also including such area of the lands surrounding the building as may be determined by the Council as being reasonably necessary in connection therewith, is exempt from taxation.

AND WHEREAS pursuant to clause (h) of section 398 of the Municipal Act, a building set apart and in use for the public worship of God a church hall which the council considers is necessary to it, the land on which the building or hall stands and an area of land surrounding the building or hall determined by Council, is exempt from taxation.

AND WHEREAS pursuant to subsection (2) of section 399 of the Municipal Act, where a portion only of any parcel is exempted under clause (h) and (k) of section 398, the Council shall by bylaw determine the area so exempted, and shall in such bylaw describe the exempted lands by a metes and bounds description and annex thereto a plan showing the portion of the lands exempted and the portion of the lands taxable, and the bylaw shall be filed in the Land Title Office for the district in which the lands are situate.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as "BURNABY TAXATION EXEMPTION BYLAW NO. 7, 1981".
2. The Council of The Corporation of the District of Burnaby does hereby exempt from taxation for the year 1982 those lands and the buildings situated thereon more particularly hereinafter described.

Commencing at the North West corner of Lot 7 of District Lot 126, Plan 3473, New Westminster District; thence in an Easterly direction along the Northern boundary of said Lot 7 a distance of 271.55 feet, thence in a Southerly direction a distance of 169.36 feet, thence in a South Easterly direction a distance of 26.68 feet; thence in a Southerly direction a distance of 84.85 feet; thence in a Westerly direction a distance of 160 feet; thence in a Southerly direction a distance of 90 feet; thence in an Easterly direction a distance of 160 feet to the Eastern boundary of Lot 8, thence a distance of 73 feet in a Southerly direction along the Eastern boundary; thence 21.25 feet in a South Westerly direction to the Southern boundary; thence in a Westerly direction a distance of 281.24 feet to the Western boundary; thence in a Northern direction a distance of 456 feet to point of commencement as shown outlined in Green colour on the sketch annexed to Bylaw No. 6189, filed in the Land Title Office at New Westminster, and marked with the letter "A".

Commencing at the North East corner of said Lot "B" of Lot 5, Blocks 5 to 9 inclusive of District Lot 96N, Plan 13781, New Westminster District; thence in a Westerly direction at a distance of 585.7 feet along the Northerly boundary of said Lot "B"; thence in a Southerly direction a distance of 120.0 feet parallel to the Westerly boundary of said Lot "B"; thence in an Easterly direction a distance of 586.0 feet along the Southerly boundary of said Lot "B"; thence in a Northerly direction a distance of 120.0 feet along the Easterly boundary of said Lot "B" to the point of commencement as shown outlined in Green colour on the plan annexed to Bylaw No. 5237 filed in the Land Title Office at New Westminster under No. C76762 and marked with the letter "E".

And also Lot "A" West Half of Lot 5, Blocks 5 to 9 inclusive, District Lot 96, Plan 6860, New Westminster District, shown outlined in Green on sketch attached to Bylaw No. 6379.

Commencing at the Southwest corner of Lot 30, District Lot 1, Group 1, Plan 28587, New Westminster District, thence in an easterly direction along the southerly boundary of said Lot 30 a distance of 416.77 feet, thence in a northerly direction parallel to the westerly boundary of said Lot 30 a distance of 646.7 feet, thence in a westerly direction, along the northerly boundary of said Lot 30 a distance of 416.77 feet, thence in a

southerly direction along the westerly boundary a distance of 646.7 feet to the point of commencement as shown outlined in Green colour on the plan annexed to Bylaw No. 5240, filed in the Land Title Office at New Westminster under No. C76763 and marked with the letter "B".
