BYLAW NO. 7858

A BYLAW to amend Bylaw No. 6333, being the
"Burnaby Building Bylaw 1973"

The Council of The Corporation of the District of
Burnaby ENACTS as follows:

1. This bylaw may be cited as "BURNABY BUILDING BYLAW
1973, AMENDMENT BYLAW NO. 2, 1981".

2. Clause (a) of section 2 of Bylaw No. 6333 is repealed
and the following substituted therefor:

"2.(a) "Bylaw" includes the "Burnaby Building Bylaw 1973",
Parts 1 to 6 inclusive, 8 and 9 of the National
Building Code of Canada 1980 and the Building
Regulations of British Columbia enacted pursuant to
section 740(1) of the Municipal Act."

3. Subsection (4) of section 5 of Bylaw No. 6333 is
repealed and the following substituted therefor:

"5.(4) If an owner requests an inspection for which no
fee is herein prescribed, he shall pay to the
Corporation a fee based on the time taken to make
such inspection at the rate of \$30.00 per hour
for the first hour or part thereof and \$10.00
per hour for each additional hour or part thereof."

4. Appendix "A", as enacted by Bylaw No. 7640, is
repealed and Appendix "A" attached hereto substituted therefor.

5. This bylaw shall come into force and effect on the 4th day of January, 1982.


