A BYLAW to amend Bylaw No. 6335, being the "Burnaby Plumbing Bylaw 1973"

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This bylaw may be cited as "BURNABY PLUMBING BYLAW 1973, AMENDMENT BYLAW NO. 2, 1981".
- 2. Section 2 of Bylaw No. 6335 is repealed and the following substituted therefor:
 - "2. In this bylaw, unless the context otherwise requires, "bylaw" means Burnaby Plumbing Bylaw 1973, the Province of British Columbia Plumbing Code 1980, and the National Fire Protection Association 13 1980, "Installation of Sprinkler Systems"."
- 3. Appendix "A" of Bylaw No. 6335, as enacted by Bylaw No. 7642, is repealed and Appendix "A" annexed hereto substituted therefor.
- 4. This bylaw shall come into force and effect on the 4th day of January, 1982.

1.	PLUMBING FIXTURES:	
	For the rough-in (and completion) of each plumbing fixture a fee of	\$ 12.00
	 Each roof drain, floor drain, swimming pool, whirl pool, hot tub, service water heater and backflow protection device 30mm in size or larger, is classed as a plumbing fixture. 	
2.	INTERCEPTORS:	
	For each installation of a catch basin, sump, oil interceptor or trench drain (manholes excluded) a fee of	\$ 14.00
3.	ALTERATION WORK:	
	For the installation or alteration of any plumbing pipe or rainwater leader where no fixtures are involved, for each 30 m of piping or portion thereof, a fee of	\$ 14.00
4.	SITE PIPING:	
	For the installation of miscellaneous site storm sewer, sanitary sewer and domestic water line, for each 30 m of piping or portion thereof on private property, a fee of	\$ 14.00
5.	SITE FIRE PROTECTION:	
	For the installation of:	
	(a) Each 30 m of underground fireline	\$ 26.00
	(b) Each fire hydrant	\$ 14.00
6.	BUILDING FIRE PROTECTION:	
	For the installation of:	
	(a) The first sprinkler head	\$ 14.00
	(b) Each additional sprinkler head	\$ 1.00
	(c) Each siamese connection	\$ 11.00
	(d) Each hose cabinet, hose, outlet, wet/dry outlet and standpipe	\$ 11.00
7.	SPECIAL INSPECTIONS:	
	Being inspections made in response to a request by a person having a legal interest in establishing the fitness of a building plumbing system, a fee of	\$ 30.00
8.	REINSPECTION FEE:	
	Where due to non-compliance with the provisions of this By-Law or to unsatisfactory workmanship, more than two inspections are necessary, then for each inspection after the second inspection a fee of	\$ 25.00
9.	PERMIT REFUND:	
	The fee paid for a permit may be refunded, less 10%, provided no work has	

been performed under the permit.
