

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 7918

A BYLAW to amend Bylaw No. 3476, being the
"Burnaby Road Acquisition and
Dedication Bylaw No. 1, 1954'

WHEREAS Bylaw No. 3476 empowered Council to acquire and dedicate for highway purposes certain lands including more particularly those lands described in Schedule "A" annexed hereto (hereinafter called "the said lands").

AND WHEREAS the said lands were acquired and dedicated as public highway.

AND WHEREAS the said lands have not been used as a public highway and no public moneys have been expended thereon.

AND WHEREAS the said lands are no longer required as a public highway.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This bylaw has been cited as "BURNABY ROAD ACQUISITION AND DEDICATION BYLAW NO. 1, 1954, AMENDMENT BYLAW 1982".
2. Those lands more particularly described in Schedule "A" annexed hereto are hereby closed up and stopped to traffic and are freed and discharged from the aforesaid dedication as a public highway.
3. Bylaw No. 3476 is amended to the extent necessary to give effect to this bylaw.

SCHEDULE "A"

- (a) ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia, and being Lot "F" of Parcel One (1), (Explanatory Plan 9474) of Lot "D", Block Eight (8) of Lot One hundred and twenty-five (125), Group One (1), Plan 14404, in the District of New Westminster; and
- (b) ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the Municipality of Burnaby and Province of British Columbia, and being an 0.642 acre portion of Lot "D", Block 8, District Lot 125, Group 1, Plan No. 3436, New Westminster District, which may be more particularly described as follows, that is to say:-

Commencing at the south-west corner of said Lot "D", thence north No degrees, twenty minutes east (N.0°20'E) a distance of Three hundred ten and forty-two one hundredths (310.42) feet more or less to the south-west corner of Lot "F", Block 8, District Lot 125, Group 1, Plan No. 9474, New Westminster District.

Thence south fifty-nine degrees, thirty-eight minutes East (S.59°38'E) a distance of One hundred fourteen and thirty-six one hundredths (114.36) feet more or less to the south-east corner of said Lot "F".

Thence south No degrees twenty minutes west (S.0°20'W.) a distance of Two hundred fifty-four and fifty-seven one hundredths (254.57) feet more less to the point of commencement as shown on the accompanying plan outlined in red and containing by admeasurement 0.642 acres be the same more or less.
