AMENDMENT BYLAW 1982.
2. Schedule "A", annexed to Bylaw No. 3089, as enacted by Bylaw
No. 7851, is repealed and Schedule "A" annexed hereto substituted
therefor.
3. This Bylaw shall come into force on the 1st day of January,
1983.
