## THE CORPORATION OF THE DISTRICT OF BURNABY BYLAW NO. 8102

A BYLAW to establish five mobile polls for the municipal elections, including submissions to the electors, on November 19, 1983.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY MOBILE POLL BYLAW 1983.
- 2. The returning officer shall establish for the municipal elections, including submissions to the electors, on November 19, 1983 five (5) mobile polls and each mobile poll shall be staffed by a deputy returning officer and three poll clerks.
- 3. The first mobile poll shall attend at the place hereinafter described and shall be open during the hours hereinafter specified:

  Burnaby General Hospital, 3935 Kincaid Street, from

  8:00 o'clock in the forenoon until 7:45 o'clock in the afternoon.
- 4. The second mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
  - (a) Seton Villa, 3755 McGill Street, from 8:00 o'clock in the forenoon until 1:30 o'clock in the afternoon;
  - (b) Finnish Manor Personal Care Home, 3460 Kalyk Avenue, from 2:15 o'clock in the afternoon until 4:30 o'clock in the afternoon;
  - (c) Dania Home, 4279 Norland Avenue, from 5:45 o'clock in the afternoon until 7:45 o'clock in the afternoon.

- 5. The third mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
  - (a) Normanna Rest Home, 7979 12th Avenue, from 8:00 o'clock in the forenoon until 10:00 o'clock in the forenoon;
  - (b) Deer Lake Private Hospital, 6907 Elwell Street, from 10:15 o'clock in the forenoon until 10:45 o'clock in the forenoon;
  - (c) George Derby Rehabilitation Centre, 7502 Cumberland Street, from 11:30 o'clock in the forenoon until 2:30 o'clock in the afternoon;
  - (d) Hall Towers #2 (Second and Third Floors), 7264
    Kingsway, from 2:45 o'clock in the afternoon until
    4:15 o'clock in the afternoon;
  - (e) Dogwood Lodge, 3755 Willingdon Avenue, from 6:00 o'clock in the afternoon until 7:45 o'clock in the afternoon.
- 6. The fourth mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
  - (a) Canada Way Personal Care Centre, 7195 Canada Way, from8:00 o'clock in the forenoon until 9:45 o'clock in the forenoon;
  - (b) New Vista Care Home, 7550 Rosewood Street, from 10:00 o'clock in the forenoon until 2:30 o'clock in the afternoon;
  - (c) Fellburn Private Hospital, 6050 Hastings Street, from 3:00 o'clock in the afternoon until 4:30 o'clock in the afternoon;
  - (d) Central Park Manor, 3730 Burke Street, from 6:00 o'clock in the afternoon until 7:45 o'clock in the afternoon.

- 7. The fifth mobile poll shall attend at the places hereinafter described and shall be open during the hours hereinafter specified:
  - (a) Swedish Rest Home, 1800 Duthie Avenue, from 8:00 o'clock in the forenoon until 11:30 o'clock in the forenoon;
  - (b) Carlton Private Hospital and Lodge, 4125 Canada Way, from 12:30 o'clock in the afternoon until 2:15 o'clock in the afternoon;
  - (c) Willingdon Private Hospital, 4435 Grange Street, from 2:30 o'clock in the afternoon until 3:15 o'clock in the afternoon;
  - (d) St. Michael's Centre, 7451 Sussex Avenue, from 3:30 o'clock in the afternoon until 5:00 o'clock in the afternoon;
  - (e) Fair Haven, 4341 Rumble Street, from 6:15 o'clock in the afternoon until 7:45 o'clock in the afternoon.
