

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 8177

A BYLAW to authorize the removal of
illegal portable signs.

WHEREAS Council may by bylaw authorize the removal of a structure or thing, in whole or in part, that contravenes a bylaw;

AND WHEREAS a number of portable signs have been erected, placed or displayed at certain locations in the municipality, contrary to the provisions of Burnaby Sign Bylaw 1972, and the owners have neglected or refused to remove the signs after being requested to do so;

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY SIGN REMOVAL AUTHORIZATION BYLAW NO. 1, 1984.
2. The Chief Building Inspector is hereby authorized to remove or cause to be removed portable signs erected, placed, or displayed contrary to Burnaby Sign Bylaw 1972 located at the properties set forth in "Schedule A" hereto attached and forming part of this Bylaw.
3. The Chief Building Inspector shall, before removing any sign pursuant to section 2, give 30 days' notice by registered mail of the contemplated action to the owner, tenant or occupier of the real property affected, and the notice shall state that an appeal lies to the County Court against the contemplated action.

4. The Chief Building Inspector shall impound the portable signs removed pursuant to section 2, and thereafter upon paying the costs of removal and impounding, an owner may recover his sign from the Chief Building Inspector.

5. If the expense of removal and impounding are not paid, the Corporation may recover the expense, with interest at the rate of six percent a year, with costs, in the same manner as municipal taxes.
