

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 8253

A BYLAW to alter a reservation of land
for ROBERT BURNABY PARK

WHEREAS by Bylaw No. 551, entitled "BURNABY PARK
DEDICATION BY-LAW D.L. 89, 1926", certain lands were defined and
set apart for park purposes, namely,

"... all of the lands comprised in Lots 1 and 2 of
Lot 89, Group 1, Map No. 4005 deposited in the Land
Registry Office at New Westminster and Lot 3 of
Lot 89, Group 1, Map No. 3064, deposited in the Land
Registry Office at New Westminster, subject however
to the reservation of sixty-six (66) feet right of way
for the purpose of the extension of the Grandview
Highway.";

AND WHEREAS Council deems it advisable to effect a
realignment of the park boundary to accommodate development of
the adjacent lands;

NOW THEREFORE the Council of The Corporation of the
District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as ROBERT BURNABY PARK
BOUNDARY REALIGNMENT BYLAW, 1984.

2. There is hereby defined and reserved for park purposes
ALL AND SINGULAR that certain parcel of land and premises
situate, lying and being in the Municipality of Burnaby and
being all that portion of Lot 313 of District Lots 87, 89 and
90, Group 1, Plan 40695, New Westminster District, which may be
described more particularly as follows:

All that portion of the said Lot 313, having
an area of 309 square metres, more or less,
as shown hatched on the explanatory plan
certified correct by Bryan S. Berting, B.C.L.S.,
on the 7th day of August, 1984, a copy of
which is hereto attached, copy of which is
hereto annexed.

3. The reservation for park purposes effected by Bylaw No. 551, being "BURNABY PARK DEDICATION BYLAW D.L. 89, 1926" is hereby removed from ALL AND SINGULAR that certain parcel of land and premises situate, lying and being in the Municipality of Burnaby, and being all that portion of Block "A", District Lot 89, Group 1, Plan 4517, New Westminster District, which may be described more particularly as follows:

All that portion of the said Block "A" having an area of 397 square metres, more or less, as shown cross-hatched on the explanatory plan certified correct by Bryan S. Berting, B.C.L.S., on the 7th day of August, 1984, a copy of which is hereto attached.

READ a first time this 20th day of AUGUST 1984.


READ a second time this 20th day of AUGUST 1984.
