

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 8350

A BYLAW to stop up and close to traffic portions of road.

WHEREAS portions of road dedicated by Bylaw No. 3677, BURNABY ROAD DEDICATION BYLAW NO. 1, 1956, are no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ROAD CLOSING BYLAW NO. 3, 1985.
2. Those portions of road situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, dedicated by Bylaw No. 3677, more particularly described as ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being Lots Four (4) and Eleven (11), Block Fifty-One (51), Lot Two (2), District Lot Ninety-Five (95), Group One (1), District of New Westminster, Province of British Columbia, Plan 2073 except part on Plan 16808 and being more particularly described as those portions of said Lots Four (4) and Eleven (11), lying adjacent to the Southwesterly boundaries thereof, having full widths of Thirty-Three feet (33.0'), and containing by estimation zero point zero ninety-five (0.095) and zero point zero ninety-two (0.092) of an acre, respectively, be the same more or less, as shown on Road Dedication Bylaw Plan filed 40995, a copy of which is attached hereto and outlined in red, are hereby stopped up and closed to traffic.

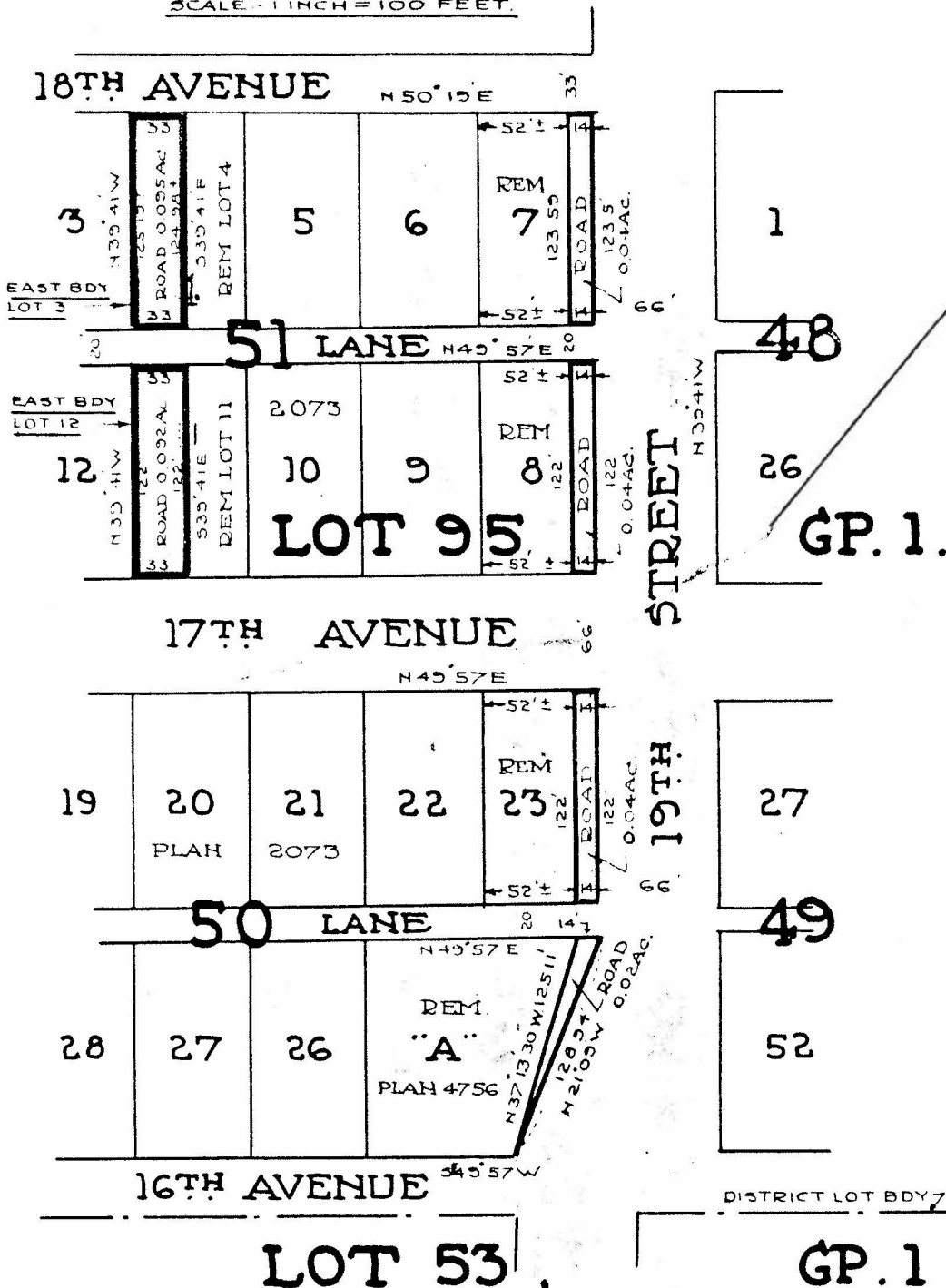
