BYLAW NO. 8386

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 400(1)(b) of the Municipal Act.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY TAXATION EXEMPTION BYLAW NO. 1, 1985.
- Pursuant to section 400(1)(b) of the Municipal Act,
 Council does hereby exempt from taxation under section 273(a),
 (b) and (c) of the said Act for the year 1986 the following
 lands and improvements, namely:
