BYLAW NO. 8428

A BYLAW to stop up and close to traffic
portion of road

WHEREAS that portion of road shown on the plan annexed hereto dedicated by Plan 15742 is no longer required for road purposes.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ROAD CLOSING BYLAW NO. 7, 1985.

2. That portion of road situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, and being more particularly known and described as all that portion of road in District Lot 59, Group 1, New Westminster District, dedicated by the deposit of Plan 15742 containing by admeasurement 55.61 m² as shown outlined on the Bylaw Plan prepared by James Davidson, B.C.L.S., certified correct the 20th day of August, 1985, a copy of which is annexed hereto, is hereby stopped up and closed to traffic.


3. The Municipal Clerk is hereby authorized and empowered to petition the Minister of Municipal Affairs to abandon the said portion of road more particularly described in section 2 hereof and vest title thereto in the name of The Corporation of the District of Burnaby.

DISTRICT DEDICATED BY PLAN 15742

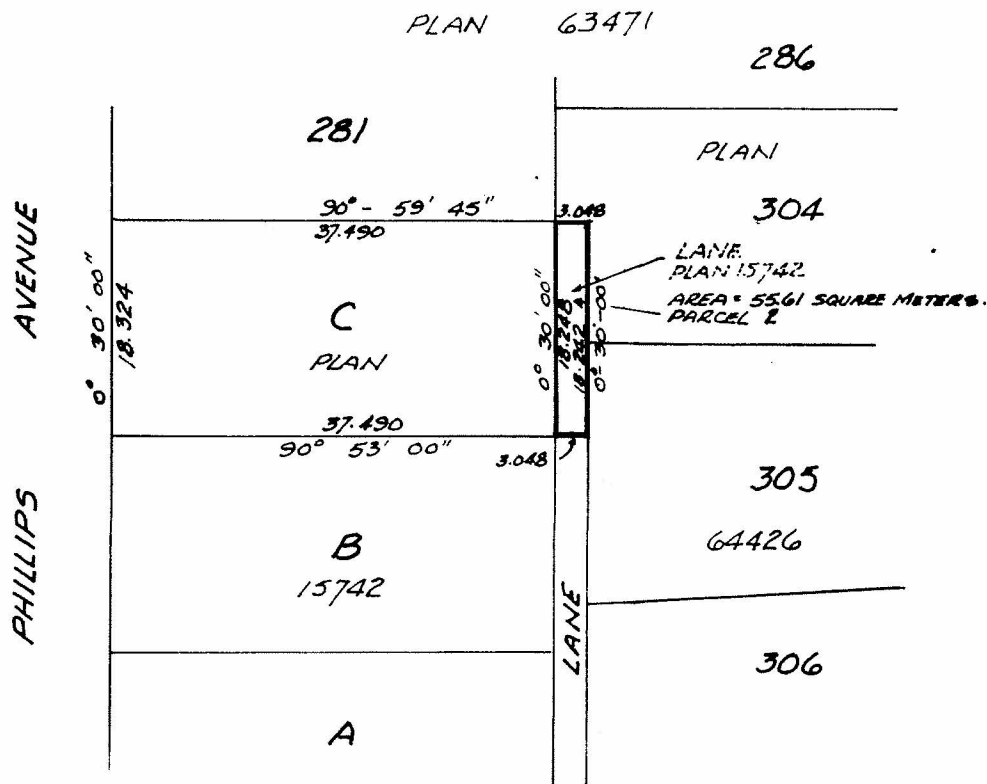
