A BYLAW authorizing the expenditure of monies in the Capital Works, Machinery and Equipment Reserve Fund

WHEREAS there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund (hereinafter called "the said Reserve Fund") established pursuant to Bylaw No. 7256 of \$23,575,662.97 as at the 18th day of May, 1986, calculated as follows:

1986.

- 2. The sum of \$540,000.00 is hereby appropriated from the said Reserve Fund to be expended for the construction of improvements to Canada Way between Norland Avenue and Kensington Avenue.
- 3. Should any of the said sum of \$540,000.00 remain unexpended after the expenditures hereby authorized have been made, any unexpended balance shall be returned to the credit of the said Reserve Fund.
