BYLAW NO. 8608

A BYLAW to exempt from taxation certain land pursuant to section 399(2) of the Municipal Act.

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY TAXATION EXEMPTION BYLAW NO. 11, 1986.
- Pursuant to section 399(2) of the Municipal Act, the Council does hereby exempt from taxation under the said Act, except for charges under sections 612(1)(a) and (c), 614, 640 and 641(1)(a), (b) and (c) of the said Act, for the year 1987, the following lands, namely:
