BYLAW NO. 8784

A BYLAW to exempt from taxation certain lands and improvements pursuant to section 400(2) of the Municipal Act

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY TAXATION EXEMPTION BYLAW NO. 11, 1987.
- 2. Pursuant to section 400(2) of the Municipal Act, Council does hereby exempt from taxation under section 273(a), (b) and (c) of the said Act for the year 1988 for fifty percent of the following lands and improvements acquired or held by the Board of School Trustees of School District No. 41 (Burnaby) and used or occupied as licensee or tenant by a non-profit organization, namely:
