

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 8891

A BYLAW to authorize the construction of
certain local improvement works
on the initiative plan

WHEREAS notice of intention of the Council to undertake the construction, as a local improvement, of the works hereinafter described has been duly given by publication of the notice and by service of it upon the owners of the parcels liable to be specially charged.

AND WHEREAS the Clerk has filed a statutory declaration proving publication and service of the said notice.

AND WHEREAS no petition against the said works signed by a majority of the owners, representing at least one-half of the land value of the parcels liable to be specially charged, has been presented.

AND WHEREAS Council has had prepared the report required by Section 662 of the Municipal Act.

AND WHEREAS the lifetime of the said works is twenty years.

AND WHEREAS the estimated cost of the said works is \$676,200.

AND WHEREAS the share or portion of the cost of the said works that should be borne by the parcels of land that abut or are deemed to abut on the said works is \$337,843.00.

AND WHEREAS the Corporation's share or proportion of the cost of the said works is \$338,357.00.

AND WHEREAS the special charges should be made payable in ten annual instalments.

AND WHEREAS the total amount proposed to be borrowed under this Bylaw, namely \$676,200, does not exceed the total amount of borrowing approved by the Inspector of Municipalities for local improvement purposes less the amount already borrowed under such authorization.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY LOCAL IMPROVEMENT CONSTRUCTION BYLAW NO. 15, 1987.

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to construct as a local improvement under the provisions of Part 16 of the Municipal Act all necessary equipment, wires, and works, including standards and underground conduits, for the purpose of supplying public lighting for the following streets:

- (a) Balmoral Street from Colbourne Avene to Sperling Avenue
- (b) Beta Avenue from Lougheed Highway south to cul-de-sac
- (c) Booth Avenue from Grafton Street to Grange Street
- (d) Burford Street from Griffiths Avenue to Imperial Street
- (e) Canada Way-Sixth Street being area generally bounded by Canada Way, Sixth Street, 11th and 19th Avenues
- (f) Carnegie Street from Kensington Avenue to Brooklyn Avenue
- (g) Chaffey Avenue from Grange Street to Burke Street
- (h) Clinton Street from Hedley Avenue west to lane east of Gilley Avenue

- (i) Eglinton Street east from west property line of Lot 172 (5734 Eglinton Street) on the south and the west property line of Lot 168 (5735 Eglinton Street) on the north to cul-de-sac
- (j) Elsom Avenue from Sardis Street to Grafton Street
- (k) Elwell Street from Canada Way to Sixth Street
- (l) Fir Street from Smith Avenue to MacDonald Avenue
- (m) Goodlad Street from Canada Way to Sixth Street
- (n) Harken Drive Area - Limits: Pioneer Avenue from Grassmere Street north to north property line of Lot B (4927 Pioneer Avenue) and on Harken Drive - Pioneer Avenue east to north property line of Lot 262 (4661 Harken Drive); and on Harken Drive from west property line of Lot 251 (4560 Harken Drive) to east property line of Lot 280 (4584 Harken Drive); and on Beamish Court - Harken Drive north to north property line of Lot 256 (4968 Beamish Court)
- (o) MacDonald Avenue from Fir Street to Pine Street
- (p) MacDonald Avenue from William Street to Kitchener Street
- (q) McKay Avenue from Rumble Street to Boxer Street
- (r) Malvern Avenue from Burris Street to Imperial Street
- (s) Napier Street from Douglas Road to Gilmore Avenue
- (t) Patterson Avenue from Kingsway south to the south property line of NW 2265, D.L. 151, Lots 1 to 238 (4134 and 4194 to Maywood Street)
- (u) Paulus Crescent area being the area bounded by Cliff Avenue, Duthie Avenue, Buchanan Street and Paulus Crescent
- (v) Price Street from Boundary Road to Smith Avenue
- (w) Randolph Avenue from Imperial Street to Bryant Street
- (x) Ridgelawn Drive from Woodway Place to Springer Avenue
- (y) Seventeenth Avenue from Canada Way to Mary Avenue
- (z) Springer Avenue from Parker Street to Lougheed Highway
- (aa) Burns Place from Kisbey Street east to cul-de-sac

3. The Mayor and Clerk are authorized and empowered to cause a contract for the construction of the said works to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council to be declared by resolution.

4. The special charges shall be paid by ten annual instalments.



The Assessor shall forthwith prepare a frontage tax assessment roll in respect of the said works pursuant to Section 483 of the Municipal Act and in accordance with the provisions of Bylaw No. 8417, as amended, and shall from time to time revise the said frontage tax assessment roll in accordance with subsection (3) of the said Section 483.
