BYLAW NO. 8996

A BYLAW to amend Bylaw No. 7600, being BURNABY ADVISORY PLANNING COMMISSION BYLAW 1980

The Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ADVISORY PLANNING COMMISSION BYLAW 1980, AMENDMENT BYLAW 1988.

2. Bylaw No. 7600 is amended by striking out the recitals preceding section 1 and substituting therefor the following:


"The Council of The Corporation of the District of Burnaby ENACTS as follows:"

3. Section 2 of the said Bylaw is amended by striking out all the words after "remuneration" and substituting therefor the following:

> "and who shall advise the Council on all matters respecting land use, community planning or proposed bylaws and permits under Divisions 1, 4, 5 and 7 of Part 29 of the Municipal Act that are referred to it by the Council."

4. Section 3 of the said Bylaw is repealed and following substituted therefor:

"3.(1) The commission shall consist of eleven members appointed by Council as follows:



- (b) a member of the Burnaby Parks and RecreationCommission, other than an alderman; and
- (c) nine residents of the municipality chosen from the community at large.

(2) Each member appointed pursuant to paragraphs (a) and (b) of subsection (1) shall hold office for the period designated by Council in the appointment.

(3) Each member appointed pursuant to paragraph (c) of subsection (1) shall hold office for two years.

(4) Where a vacancy exists in the membership of the commission, Council may appoint a person to serve the balance of the term of appointment.

(5) A member of the commission is eligible for reappointment, but no person shall serve for more than six consecutive years."

(6) A member who is absent from three consecutive meetings of the commission without leave of the commission or without reason satisfactory to the commission shall forthwith cease to be a member."

5. Section 6 of the said Bylaw is repealed and the following substituted therefor:

"6. Meetings of the commission shall be at the call of the chairman."

6. Section 7(2) of the said Bylaw is repealed and the following substituted therefor:

"(2) Notwithstanding subsection (1),

- (a) where the commission is considering an amendment to a plan or bylaw, or the issue of a permit, the applicant for the amendment or the permit is entitled to attend at meetings of the commission and be heard, and
- (b) any person may request permission to attend and be heard at a meeting of the commission giving a reason for the request, and the commission shall decide whether the person shall be admitted to the whole or a part of any meeting and who shall be heard."
- 7. Section 8 of the said Bylaw is repealed.
- 8. Schedule "A" of the said Bylaw is repealed.
