The Comprehensive Development Plan entitled CARETAKER SUITE, KINGDOM HALL prepared by PETER BAKER, ARCHITECT and on file in the office of the Director Planning and Building Inspection, is deemed to be attached to and form part of this Bylaw and any development on the lands rezoned by this Bylaw shall be in conformity with the said Comprehensive Development Plan."


