

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 9126

A BYLAW to amend Bylaw No. 6191, being  
Burnaby Dog Tax and Pound and  
Animal Regulation Bylaw 1972

The Council of The Corporation of the District of  
Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY DOG TAX AND POUND AND ANIMAL REGULATION BYLAW 1972, AMENDMENT BYLAW 1988.

2. Section 3(1) of BURNABY DOG TAX AND POUND AND ANIMAL REGULATION BYLAW 1972 is repealed and the following substituted therefor:

"3.(1) Every person within the Municipality who owns a dog shall have a valid and subsisting licence for the dog issued by the Licence Inspector of the Corporation upon payment of the fee prescribed in Schedule 'D'."

3. The said Bylaw is amended by adding thereto after Schedule "C" thereof, the following Schedule "D":

"SCHEDULE 'D'  
DOG LICENCE FEES

	<u>Paid before</u> <u>March 1</u>	<u>Paid on or</u> <u>after March 1</u>
Male dog	\$30.00	\$35.00
Neutered male dog	12.00	14.00
Female dog	30.00	35.00
Spayed female dog	12.00	14.00"

4. Clause (c) of section 5 of the said Bylaw is repealed and the following substituted therefor:

"(c) The penalty for a violation of clause (a) of this section is \$32.00 if the dog is licensed and \$51.50 plus licence fee if the dog is unlicensed."

5. Schedule "A" of the said Bylaw is amended by repealing Items (1) and (2) and substituting therefor the following:

"(1) for a licensed dog

- (a) first impoundment ..... \$ 25.00
- (b) second impoundment ..... \$ 50.00
- (c) third and subsequent impoundments ..... \$100.00

(2) For an unlicensed dog

- (a) first impoundment ..... \$50.00 plus licence fee
- (b) second impoundment ..... \$100.00 plus licence fee
- (c) third and subsequent  
impoundments ..... \$150.00 plus licence fee"

6. (1) Item (1) of Schedule "B" is amended by striking out "\$5.40" and substituting therefor "\$5.60".

(2) Item (4) of Schedule "B" is repealed and the following substituted therefor:

"(4) For any animal not listed in (1),  
(2) or (3), including a cat ..... \$2.40 per day or  
part of a day" |

7. Items (3), (4) and (5) of Schedule "C" are repealed and the following substituted therefor:

"(3) For each dead body of a cat or dog ... \$.23 per pound  
with a minimum  
charge of \$5.60

(4) In addition to fee specified in  
(1), (2) and (3), all costs of  
removal and disposal are payable

(5) Licensed veterinarians and other  
agencies approved by Council shall  
pay for disposal ..... \$.23 per pound  
with a minimum  
charge of \$5.60"



7. This Bylaw shall come into force and effect on the 1st day of January, 1988.
