BYLAW NO. 9141

A BYLAW to dispose of a certain portions of
highway in exchange for other land

WHEREAS pursuant to section 574 of the Municipal Act R.S.B.C. 1979 the Council may by bylaw dispose of any portion of a highway in exchange for such lands as may be necessary for the purpose of improving, widening, straightening, relocating or diverting a highway.

AND WHEREAS all deeds executed under this section have effect as a Crown grant, free of all rights of way, and all lands taken in exchange for any portion of a highway under this section are public highways, and the title thereto is vested in the Crown.

AND WHEREAS the Council, before adopting this Bylaw, has caused the required statutory public notice of its intention to be given by advertisement.

AND WHEREAS the Council deems it expedient and in the public interest to stop up and close to traffic those portions of highway more particularly hereinafter described for the purpose of relocating and diverting a highway.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY HIGHWAY EXCHANGE BYLAW NO. 2, 1989.

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to stop up and close to traffic ALL AND SINGULAR those certain parcels or tracts of land, situate, lying and being in the Municipality of Burnaby, in the Province of British Columbia, more particularly known and described as all those portions of lane in

- (a) District Lot 95, Group 1, New Westminster District, dedicated by Plan 76774, containing 325.3 m², and
- (b) District Lot 95, Group 1, New Westminster District, dedicated by Plan 1915, containing 273.6 m²,

(hereinafter called "the said closed portions of lane") and shown hatched on Reference Plan prepared by Dick F. Mak, B.C.L.S., deposited in the Land Title Office under Number _____, a copy of which is hereunto annexed (hereinafter called "the said plan").

3. The Council is further authorized and empowered to grant and convey the said closed portions of lane unto the registered owners of:

- (a) South Easterly 10 feet Lot "C", District Lot 95, Group 1, New Westminster District, Plan 5860 being measured at right angles to the south east boundary;
- (b) North Westerly 10 feet Lot 37, District Lot 95, Group 1, measured at right angles to the north west boundary, New Westminster District, Plan 1152;
- (c) North Westerly 10 feet Lot 38, District Lot 95, Group 1, measured at right angles to the north west boundary; New Westminster District, Plan 1152;
- (d) Lot 37 Except: the north westerly 10 feet measured at right angles to the north west boundary, District Lot 95, Group 1, New Westminster District, Plan 1152;
- (e) Lot 38 Except the north westerly 10 feet, District Lot 95, Group 1, New Westminster District, Plan 1152;
- (f) Lot 19, District Lot 95, Group 1, New Westminster District, Plan 1915;
- (g) Lot 18, District Lot 95, Group 1, New Westminster District, Plan 1915;
- (h) Lot 17, District Lot 95, Group 1, New Westminster District, Plan 1915;

(hereinafter called "the said lots") in exchange for that portion of the said lots containing 288.0 m² shown outlined on the said


plan, and that portion of the said lots shall, upon deposit of the necessary transfers in the Land Title Office, be public highway and title thereto shall be vested in the Crown.
