The Comprehensive Development Plan entitled PROPOSED AMENDMENTS APARTMENT COMPONENT THE STATION SQUARE DEVELOPMENT AT METROTOWN prepared by HAMILTON, DOYLE ARCHITECTS and on file in the office of the Director Planning and Building Inspection, is deemed to be attached to and form part of this Bylaw and any development on the lands rezoned by this Bylaw shall be in conformity with the said Comprehensive Development Plan."


