



THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 9182

A BYLAW to authorize the construction of certain local improvement works on the initiative plan

WHEREAS notice of intention of the Council to undertake the construction, as a local improvement, of the works hereinafter described has been duly given by publication of the notice and by service of it upon the owners of the parcels liable to be specially charged;

AND WHEREAS the Clerk has filed a statutory declaration proving publication and service of the said notice;

AND WHEREAS no petition against the said works signed by a majority of the owners, representing at least one-half of the land value of the parcels liable to be specially charged, has been presented;

AND WHEREAS Council has had prepared the report required by Section 662 of the Municipal Act;

AND WHEREAS the lifetime of the said works is twenty years;

AND WHEREAS the estimated cost of the said works is \$576,725;

AND WHEREAS the share or portion of the cost of the said works that should be borne by the parcels of land that abut or are deemed to abut on the said works is \$353,315.17; AND WHEREAS the Corporation's share or proportion of the cost of the said works is \$223,409.83;

AND WHEREAS the special charges should be made payable in ten annual instalments.

AND WHEREAS the total amount proposed to be borrowed under this Bylaw, namely \$576,725, does not exceed the total amount of borrowing approved by the Inspector of Municipalities for local improvement purposes less the amount already borrowed under such authorization.

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

 This Bylaw may be cited as BURNABY LOCAL IMPROVEMENT CONSTRUCTION BYLAW NO. 3, 1989.

2. The Council of The Corporation of the District of Burnaby is hereby authorized and empowered to construct as a local improvement under the provisions of Part 16 of the Municipal Act all necessary equipment, wires, and works, including standards and underground conduits, for the purpose of supplying public lighting for the following streets:

- (a) Bond Street from Halley Avenue west to the west property line of Lot 12 (4179 Bond Street)
- (b) Bryant Court from Griffiths Avenue west to cul-de-sac
- (c) Bryant Street from Sperling Avenue to Griffiths Avenue
- (d) Buchanan Street from Holdom Avenue to Buchanan Drive
- (e) Cliff Avenue from Union Street to Curtis Street
- (f) Cliff Avenue from Curtis Street to Broadway
- (g) Clinton Street from Boundary Road to dead end east of Joffre Avenue, to the east property line of Lot K (3855 Clinton Street)

- (h) Curle Avenue from Canada Way to Avondale Street (i) Dufferin Avenue from Irving Street south to the south property line of Rem. Lot 13 (6625 Dufferin Avenue) (j) Eighteenth Avenue from Canada Way to Mary Avenue (k) Fell Avenue from Pandora Street to Dundas Street (1)Fulwell Street from Canada Way to Westminster Avenue Gilley Avenue from the lane north of Imperial Street (m) to 20 m north of south property line of Lot K, Block 6, D.L. 93 (6292 Dickens Street) (n) Hardwick Street from Canada Way to Douglas Road Holly Street from Mary Avenue to Humphries Avenue (0) Irmin Street from Boundary Road to Joffre Avenue (p) (q) Leibly Avenue from Morley Street to Imperial Street (r) Morley Street from Walker Avenue to Malvern Avenue (s) Nelson Avenue from Bond Street to Grange Street (t) Neville Street from Plum Avenue to Curragh Avenue (u) Neville Street from Gilley Avenue to Hedley Avenue (v) Portland Street from Nelson Avenue west to dead end (w) Price Street from Chesham Avenue to Patterson Avenue Rugby Street from Gordon Avenue north on Rugby Street (x) and east to cul-de-sac, west to west property line of Lot 5, D.L. 85 (5416 Rugby Street) (y) Sardis Crescent from Nelson Avenue to Grafton Street (z) Selma Avenue from Oakland Street south to south property line of Lot 4, D.L. 94, Plan 1117 (6489 Selma Avenue) (aa) Sussex Avenue from Beresford Street to Imperial Street (bb) Sussex Avenue from Imperial Street to Rumble Street (cc) Telford Avenue from Central Boulevard to 86 m north of Maywood Street
- (dd) Union Street from Delta Avenue to Holdom Avenue
- (ee) Union Street from Cliff Avenue to east property line of Lot 301, D.L. 207, Plan 48674 (7316 Union Street) (ff) Winnifred Street from Bradley Avenue to Sussex Avenue

- (gg) Grassmere Street/Sussex Avenue area from area bounded by Willingdon Avenue, Grassmere Street, Sussex Avenue and Bond Street to include all streets in area and the 5400 block Sussex Avenue, except Willingdon Avenue and a portion of Grassmere Street from the west property line of Lot A, D.L. 33 (4675 Grassmere Street) to Sussex Avenue
- (hh) Stratford Avenue from Pandora Street to Hastings Street(ii) Wilson Avenue from Kemp Street to Central Boulevard

3. The Municipal Clerk is authorized and empowered to cause a contract for the construction of the said works to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council to be declared by resolution.

4. The special charges shall be paid by ten annual instalments.

5. The Assessor shall forthwith prepare a frontage tax assessment roll in respect of the said works pursuant to Section 483 of the Municipal Act and in accordance with the provisions of Bylaw No. 8417, as amended, and shall from time to time revise the said frontage tax assessment roll in accordance with subsection (3) of the said Section 483.
