BYLAW NO. 9252

A BYLAW to exempt from taxation certain lands pursuant to section 399(2) of the Municipal Act

The Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY TAXATION EXEMPTION BYLAW NO. 12, 1989.
- 2. Pursuant to section 399(2) of the Municipal Act, the Council does hereby exempt from taxation under the said Act, except for charges under sections 612(1)(a) and (c), 614, 640 and 641(1)(a), (b) and (c) of the said Act, for the year 1990, the following lands, namely:

"IGLESIA NI CRISTO" CHURCH OF CHRIST 5060 Marine Drive ROLL NO. 3700-5060

That portion of land occupied by "Iglesia Ni Cristo" Church of Christ described as follows:

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby and being composed of Lot 42, District Lot 162, Group 1, New Westminster District, Plan 43643, Province of British Columbia, save and except the 10,787 square meters as shown as areas "A" and "B" on plan annexed to Bylaw No. 9252 filed in the Land Title Office at New Westminster.




