BYLAW NO. 9254

A BYLAW to amend Bylaw No. 4742, being Burnaby Zoning Bylaw 1965

The Council of The Corporation of the District of Burnaby ENACTS as follows:

This Bylaw may be cited as BURNABY ZONING BYLAW 1965,
AMENDMENT BYLAW NO. 54, 1989.

- 2. Section 3 of Burnaby Zoning Bylaw 1965 is amended
 - (a) by repealing the definitions "group home" and "rest home", and
 - (b) by substituting therefor, immediately after the definition "grade or grade level, finished", the following definition: "group home' means a residential care facility for not more than six persons in care that is operated in a private dwelling house and licensed under the Community Care Facility Act;"

3. The said Bylaw is amended by adding thereto, immediately after section 6.8, the following section: "6.8A Group Homes: No group home shall be located within a 200 m

9. Subsection (4) of Section 106.1 of Schedule No. I is repealed and the following substituted therefor: "(4) Group homes on lots with area not less than

10. Subsection (1) of Section 201.1 of Schedule No. II is repealed and the following substituted therefor: "(1) Uses, other than group homes, permitted in the R6 Residential District, subject to the regulations contained therein."
