BYLAW NO. 9395

A BYLAW to amend Burnaby Zoning Bylaw 1965
respecting child care facilities

The Council of The Corporation of the District of
Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY ZONING BYLAW 1965,
AMENDMENT BYLAW NO. 28, 1990.

2. Section 3 of Burnaby Zoning Bylaw 1965 is amended
 - (a) by adding thereto, immediately after the definition
"central veterinary hospital", the following definition:

"child care facility" means any community care
facility for children licensed under the
Community Care Facility Act other than a
facility for residential care for children;"

 - (b) by adding to the definition "floor area ratio",
immediately after paragraph (1)(f), the following
paragraph:

"(g) any portion of a basement or cellar
containing a child care facility;"

3. Section 201.1 of Schedule No. II of the said Bylaw is
amended by adding thereto, after Item (6), the following:

"(7) Child care facilities that are not located
in a dwelling unit."

4. Section 202.1 of Schedule No. II of the said Bylaw is amended by adding thereto, after Item (6), the following:

"(7) Child care facilities that are not located
in a dwelling unit."

5. Section 203.1 of Schedule No. II of the said Bylaw is amended by adding thereto, after Item (6), the following:

"(7) Child care facilities that are not located
in a dwelling unit."

6. Section 204.1 of Schedule No. II of the said Bylaw is amended by adding thereto, after Item (2), the following:

"(3) Child care facilities that are not located
in a dwelling unit."

7. Section 205.1 of Schedule No. II of the said Bylaw is amended by adding thereto, after Item (3), the following:

"(4) Child care facilities that are not located
in a dwelling unit."

8. Section 501.1 of Schedule No. V of the said Bylaw is amended by repealing Item (2) and substituting therefor the following:

"(2) Kindergartens and child care facilities."

9. Section 505.1 of Schedule No. V of the said Bylaw is amended by repealing Item (3) and substituting therefor the following:

"(3) Kindergartens and child care facilities."

10. Section 800.4 of Schedule No. VII of the said Bylaw is amended by adding to the TABLE therein, immediately after Item 5, the following:


<u>Use</u>	<u>Required Parking Spaces</u>
"(5.1) Child care facility	1 for each 2 employees plus 1 for each 10 spaces licensed for the facility."


