

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 9487

A BYLAW to amend Bylaw No. 6191, being  
Burnaby Dog Tax and Pound and  
Animal Regulation Bylaw 1972

The Council of The Corporation of the District of  
Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY DOG TAX AND POUND AND  
ANIMAL REGULATION BYLAW 1972, AMENDMENT BYLAW NO. 2, 1990.

2. Clause (c) of section 5 of Burnaby Dog Tax and Pound and  
Animal Regulation Bylaw 1972 is repealed and the following  
substituted therefor:

"(c) The penalty for a violation of clause (a) of this  
section is \$35.00 if the dog is licensed and \$57.25  
plus licence fee if the dog is unlicensed."

3. Items (1) and (2) of Schedule "A" of the said Bylaw are  
repealed and the following substituted therefor:

"(1) For a licensed dog

(a) first impoundment	\$ 27.80
(b) second impoundment	55.65
(c) third and subsequent impoundments	111.30

(2) For an unlicensed dog

(a) first impoundment	\$ 55.65 plus licence fee
(b) second impoundment	111.30 plus licence fee
(c) third and subsequent impoundments	166.95 plus licence fee"

4. Items (1) and (4) of Schedule "B" of the said Bylaw are  
repealed and the following substituted therefor:

- "(1) For each dog \$6.25 per day or part of a day
- (4) For any animal not listed in (1), (2) or (3), including a cat \$2.65 per day or part of a day"

5. Items (3) and (5) of Schedule "C" of the said Bylaw are repealed and the following substituted therefor:

- "(3) For each dead body of a cat or dog \$.25 per pound with a minimum charge of \$6.25
- (5) Licensed veterinarians and other agencies approved by Council shall pay for disposal \$.25 per pound with a minimum charge of \$6.25"

6. Schedule "D" of the said Bylaw is repealed and the following substituted therefor:

"SCHEDULE 'D'  
Dog Licence Fees

	<u>Paid Before March 1, 1991</u>	<u>Paid on or after March 1, 1991</u>
Male or female dog	\$31.25	\$39.75
Neutered or spayed dog	12.50	15.90"



7. This Bylaw shall come into force on the 1st day of January 1991.
