BYLAW NO. 9493

A BYLAW to amend Burnaby Business Licence Bylaw

The Council of The Corporation of the District of Burnaby ENACTS as follows:


1. This Bylaw may be cited as BURNABY BUSINESS LICENCE BYLAW, AMENDMENT BYLAW 1990.
2. Paragraphs A and B of section 14 of Burnaby Business Licence Bylaw are amended by striking out "\$50,000" wherever it appears therein and substituting therefor "Two Million Dollars".
3. Schedule "A" of the said Bylaw is repealed and Schedule "A" annexed hereto substituted therefor.
3. This Bylaw shall come into force on the 1st day of January 1991.
