

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 9533

A BYLAW to amend Bylaw No. 4231, being the  
Burnaby Sewer Charge Bylaw 1961

The Council of The Corporation of the District of  
Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY SEWER CHARGE BYLAW  
1961, AMENDMENT BYLAW 1991.

2. Section 4A of Bylaw No. 4231, as enacted by Bylaw No.  
9119, is repealed and the following substituted therefor:

"4A.(1) The user classified hereunder shall pay for the use of  
the municipal sewerage system the annual charge hereinafter  
specified:

(a) the owner of any strata lot (not being part of a  
duplex) shall pay an annual charge of \$57.40;

(b) the owner of any multiple-family dwelling (except  
a duplex) used exclusively for residential purposes  
shall pay for each apartment unit therein an annual  
charge of \$57.40; and

(c) the owner of an apartment unit forming part of a  
duplex shall pay an annual charge of \$26.60.

(2) The charges payable pursuant to this section shall be  
collected in the same manner and with like remedies as  
ordinary taxes upon land and improvements are collectable  
under the Municipal Act."

3. Schedule "A" of Bylaw No. 4231, as enacted by Bylaw No. 9919, is repealed and the following substituted therefor:

"SCHEDULE 'A'

MONTHLY

First 38 cubic meters per month	no charge
Next 250 cubic meters per month	\$0.235 per cu. meter
Next 300 cubic meters per month	\$0.193 per cu. meter
Next 850 cubic meters per month	\$0.151 per cu. meter
In excess of 1,438 cubic meters per month	\$0.129 per cu. meter

QUARTERLY

First 114 cubic meters per quarter	no charge
Next 750 cubic meters per quarter	\$0.235 per cu. meter
Next 900 cubic meters per quarter	\$0.193 per cu. meter
Next 2,550 cubic meters per quarter	\$0.151 per cu. meter
In excess of 4,314 cubic meters per quarter	\$0.129 per cu. meter"
