A BYLAW to authorize an Agreement with the Board of School Trustees to contribute to the cost of facilities

WHEREAS Council is authorized by section 682 of the Municipal Act to enter into an agreement with the Board of School Trustees to contribute to the cost of construction, maintenance, operation or use of facilities for community uses, on a site the title of which is vested in or is held by a party to the Agreement;

AND WHEREAS The Board of School Trustees of School District No. 41 (Burnaby) is the registered owner of the lands situated in the Municipality of Burnaby and known as Burnaby North Secondary School;

AND WHEREAS Council is desirous of contributing the amount of Twenty-five Thousand Dollars (\$25,000) to the cost of developing a softball backstop at Burnaby North Secondary School;

NOW THEREFORE the Council of The Corporation of the District of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY COMMUNITY FACILITIES CONTRIBUTION AGREEMENT BYLAW NO. 1, 1991.
- 2. The Council is hereby authorized and empowered to enter into the Agreement contained in Schedule "A" with The Board of School Trustees of School District No. 41 (Burnaby) to contribute Twenty-five Thousand Dollars (\$25,000) to the cost of developing a softball backstop at Burnaby North Secondary School.
