

THE CORPORATION OF THE DISTRICT OF BURNABY

BYLAW NO. 9717

A BYLAW to relocate a certain portion of lane  
between 17th Avenue and 18th Avenue

WHEREAS pursuant to section 578 of the Municipal Act  
R.S.B.C. 1979 the Council may by bylaw authorize the relocation  
of a highway;

AND WHEREAS the Municipality is the registered owner of  
that portion of highway more particularly hereinafter described;

AND WHEREAS the Council deems it expedient and in the  
public interest to stop up and close to traffic that portion of  
highway more particularly hereinafter described for the purpose  
of relocating and diverting a highway;

NOW THEREFORE the Council of The Corporation of the  
District of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY HIGHWAY RELOCATION  
BYLAW 1992.
  
2. The Council of The Corporation of the District of  
Burnaby is hereby authorized and empowered to stop up and close  
to traffic ALL AND SINGULAR that certain parcel or tract of land,  
situate, lying and being in the Municipality of Burnaby, in the  
Province of British Columbia, more particularly known and  
described as:
  - (a) Parcel Identifier: 012-007-854  
South Easterly 10 feet Lot 47, District Lot 95,  
Group 1, measured at right angles to the South East  
Boundary, New Westminster District, Plan 1152
  
  - (b) Parcel Identifier: 012-007-897  
South Easterly 10 feet Lot 48, District Lot 95,  
Group 1, measured at right angles to the South East  
Boundary and adjoining Lot 59, New Westminster  
District, Plan 1152

- (c) Parcel Identifier: 012-008-010  
South Easterly 10 feet Lot 49, District Lot 95,  
Group 1, measured at right angles to the South East  
Boundary and adjoining Lot 58, New Westminster  
District, Plan 1152
- (d) Parcel Identifier: 012-008-222  
North Westerly 10 feet Lot 58, District Lot 95,  
Group 1, measured at right angles to the North West  
Boundary and adjoining Lot 49, New Westminster  
District, Plan 1152
- (e) Parcel Identifier: 012-012-874  
North Westerly 10 feet Lot 59, District Lot 95,  
Group 1, measured at right angles to the North West  
Boundary, New Westminster District, Plan 1152
- (f) Parcel Identifier: 012-008-231  
North Westerly 10 feet Lot 60, District Lot 95,  
Group 1, measured at right angles to the North West  
Boundary, New Westminster District, Plan 1152

(hereinafter called "the said closed portion of lane").

3. The Council is further authorized and empowered to relocate the highway from the said closed portion of lane to Lot 2, District Lot 95, Group 1, New Westminster District, Plan LMP\_\_\_\_\_ (hereinafter called the new lane), and to transfer title to the said closed portion of lane to the owner of Lot 1, District Lot 95, Group 1, New Westminster District, Plan LMP\_\_\_\_\_, in exchange for the new lane and other valuable consideration.
