BYLAW NO. 9797

A BYLAW to amend Burnaby Business Licence Bylaw

The Council of the City of Burnaby ENACTS as follows:

1. This Bylaw may be cited as BURNABY BUSINESS LICENCE BYLAW, AMENDMENT BYLAW 1992.

2. Section 8 of Burnaby Business Bylaw is amended by adding thereto after subsection (2) the following subsection:

"(3) No fee shall be charged for a transfer of licence where the administrative offices of a business are relocated within the same building."

3. Section 16 of the said Bylaw is amended

(a) by renumbering paragraph (b) as subsection (1) of section 16; and

(b) by adding thereto, after subsection (1), the following subsection:

"(2) No person shall canvass or solicit on any street or from door to door in the Municipality for the sale of security services to householders."

4. The said Bylaw is further amended by repealing Schedule "A" and substituting therefor the following:


