CITY OF BURNABY

BYLAW NO. 9797

A BYLAW to amend Burnaby Business Licence Bylaw

The Council of the City of Burnaby ENACTS as follows:

- 1. This Bylaw may be cited as BURNABY BUSINESS LICENCE BYLAW, AMENDMENT BYLAW 1992.
- 2. Section 8 of Burnaby Business Bylaw is amended by adding thereto after subsection (2) the following subsection:
 - "(3) No fee shall be charged for a transfer of licence where the administrative offices of a business are relocated within the same building."
- 3. Section 16 of the said Bylaw is amended
 - (a) by renumbering paragraph (b) as subsection (1) of section 16; and
 - (b) by adding thereto, after subsection (1), the following subsection:
 - "(2) No person shall canvass or solicit on any street or from door to door in the Municipality for the sale of security services to householders."
- 4. The said Bylaw is further amended by repealing Schedule "A" and substituting therefor the following:
